Report on the Audit of the Standalone Financial Statements

#### Opinion

We have audited the accompanying standalone financial statements of THE COLABA LAND & MILL COMPANY LIMITED ("the Company"), which comprise the Standalone Balance Sheet as at March 31, 2023, the Statement of Profit and Loss and Cash Flow Statement for the year then ended and notes to the standalone financial statements, including a summary of the significant Accounting Policies and other explanatory information (hereinafter referred to as "the Standalone Financial Statements").
